1. **DATA, HORA E LOCAL:** Realizada em 11 de agosto de 2025, às 10:00, na sede da **ALPER TECH LTDA.** ("Sociedade"), com sede na cidade de São Paulo, estado de São Paulo, na Rua Libero Badaró, nº 158, conjunto 171, 17º andar, Centro, CEP 01008-000.

2. **CONVOCAÇÃO E PRESENÇA:** A convocação foi dispensada nos termos do art. 1.072, § 2º, da Lei nº 10.406, conforme alterada, em razão da presença da sócia única, **ALPER CONSULTORIA E CORRETORA DE SEGUROS S.A.**, sociedade por ações, com sede na cidade de São Paulo, estado de São Paulo, na Rua Gilberto Sabino, nº 215, 13º andar, parte, Pinheiros, CEP 05425-020, inscrita no Cadastro Nacional da Pessoa Jurídica do Ministério da Fazenda ("CNPJ") sob o nº 11.721.921/0001-60 ("Sócia"), neste ato representada na forma de seu Estatuto Social.

3. **MESA:** Sr. Marcos Aurélio Couto, Presidente; e o Sr. Guilherme Silveira Barrozo Netto, Secretário.

4. **ORDEM DO DIA:** Deliberar sobre:

(a) a autorização para a outorga, pela Sociedade, de garantia de Fiança (adiante definida) em garantia das Obrigações Garantidas (conforme abaixo definidas) assumidas pela Sócia em favor dos titulares de Debêntures ("Debenturistas"), no âmbito da 1ª (primeira) emissão de 375.000 (trezentas e setenta e cinco mil) debêntures simples da Sócia, não conversíveis em ações, em 2 (duas) séries, da espécie com garantia real, com garantia fidejussória adicional, em rito automático de distribuição, para distribuição pública ("Emissão", sendo as debêntures da primeira série, "Debêntures da Primeira Série" e as debêntures da segunda série, "Debêntures da Segunda Série" e ambas quando em conjunto, as "Debêntures"), sendo o valor total da emissão equivalente a R\$ 375.000.000,00 (trezentos e setenta e cinco milhões de reais), na Data de Emissão (conforme definidas na Escritura), sendo: (a) R\$ 275.000.000,00 (duzentos e setenta e cinco milhões de reais) no âmbito das Debêntures da Primeira Série; e (b) R\$ 100.000.000,00 (cem milhões de reais) no âmbito das Debêntures da Segunda Série) ("Valor Total da Emissão"), nos termos do artigo 59 da Lei nº 6.404, de 15 de dezembro de 1976, conforme alterada, mediante a celebração do "*Instrumento Particular de Escritura da 1ª (Primeira) Emissão de Debêntures Simples, Não Conversíveis em Ações, da Espécie com Garantia Real, com Garantia Fidejussória Adicional, em 2 (Duas) Séries, para Distribuição Pública, sob o Rito de Registro Automático, da Alper Consultoria e Corretora De Seguros S.A.*" ("Escritura" ou "Escritura de Emissão"), a ser celebrado entre a Sócia e a **VÓRTX**

DISTRIBUIDORA DE TÍTULOS E VALORES MOBILIÁRIOS LTDA., instituição financeira, com sede na cidade de São Paulo, estado de São Paulo, na Rua Gilberto Sabino, nº 215, 4º andar, Pinheiros, CEP 05425-020, inscrita no CNPJ sob o nº 22.610.500/0001-88, na qualidade de representante dos interesses dos titulares das Debêntures ("Agente Fiduciário"), a Sociedade e a Alper Tech Ltda. ("Alper Tech" e, quando em conjunto com a Sociedade, as "Fiadoras"), na qualidade de Fiadoras. A Sociedade renuncia expressamente aos benefícios de ordem, direitos e faculdades de exoneração de qualquer natureza previstos nos artigos 333, parágrafo único, 364, 365, 366, 368, 821, 827, 829, parágrafo único, 830, 834, 835, 836, 837, 838 e 839 da Lei n.º 10.406, de 10 de janeiro de 2002, conforme alterada, e dos artigos 130, 131 e 794 da Lei n.º 13.105, de 16 de março de 2015, conforme alterada, obrigando-se solidariamente com a Sócia, em caráter irrevogável e irretratável, na condição de coobrigado, perante os Debenturistas, representados pelo Agente Fiduciário, como Fiadoras e solidariamente (entre si e com a Sócia), até a quitação integral das Obrigações Garantidas ("Fiança"); e

(b) a autorização à administração da Sociedade para discutir, negociar e definir os termos e condições da outorga da Fiança e praticar todos os atos necessários à outorga da Fiança, incluindo, sem se limitar, a celebração de todos e quaisquer contratos e/ou documentos e seus eventuais aditamentos, à Escritura, bem como os demais contratos e/ou documentos relacionados à outorga da Fiança e à Emissão, observados os limites aqui previstos; e a ratificação de todos os atos já praticados pela administração da Sociedade, direta ou indiretamente, por meio de procuradores devidamente constituídos, conforme aplicável, relacionados às matérias acima.

5. DELIBERAÇÕES: Após o exame, a discussão e a votação das matérias constantes da Ordem do Dia, a Sócia, representando a totalidade do capital social da Sociedade, deliberou, sem quaisquer restrições ou ressalvas:

(a) aprovar a outorga, pela Sociedade, da garantia de Fiança, conforme descrito pelo item **(a)** da Ordem do Dia, em garantia do pagamento integral de todos e quaisquer valores, principais ou acessórios, presentes ou futuros, incluindo Encargos Moratórios (conforme definido na Escritura), devidos pela Sócia em decorrência das Debêntures, da Escritura de Emissão e dos Contratos de Cessão Fiduciária (conforme definido na Escritura), bem como eventuais indenizações de qualquer natureza e qualquer honorário (incluindo a remuneração do Agente Fiduciário e demais prestadores de serviços da Emissão), tributo, custo ou, todo e qualquer custo ou despesa comprovadamente incorrido pelo Agente Fiduciário e/ou pelos Debenturistas em decorrência de processos, procedimentos e/ou outras medidas judiciais ou extrajudiciais necessários à salvaguarda de seus direitos e prerrogativas decorrentes das Debêntures, e/ou da Escritura de Emissão e/ou dos Contratos de Cessão Fiduciária ("Obrigações Garantidas"). As condições da Emissão e da Oferta não elencadas na presente ata serão detalhadamente estabelecidas na Escritura de Emissão e/ou nos Contratos de Cessão Fiduciária; e

(b) autorizar a administração e/ou os representantes legais da Sociedade a adotarem todas e quaisquer providências, atos e medidas necessárias e/ou convenientes à efetivação, formalização, efetivação, implementação e/ou aperfeiçoamento das deliberações tomadas, inclusive, mas sem se limitar, a negociar e firmar quaisquer instrumentos, contratos, aditamentos e documentos relacionados à Emissão, bem como à prática de atos relacionados ao registro dos documentos de natureza societária perante os órgãos competentes, incluindo providências perante às juntas comerciais competentes, à B3, à CVM, cartórios de registro de títulos e documentos, ou quaisquer outras autarquias ou órgãos perante aos quais seja necessária a adoção de quaisquer medidas para o aperfeiçoamento da Fiança e para a implementação e divulgação da Emissão e/ou da Oferta; e

(c) ratificar todos os atos já praticados pela administração e/ou representantes legais da Sociedade relacionados às matérias deliberadas nos itens (a) e (b) acima.

6. ENCERRAMENTO: Nada mais havendo a ser tratado, foi encerrada a reunião e lavrada a presente ata na forma de sumário, que após lida e aprovada, foi assinada pela Sócia.
